Class Counsel hereby request a four-week continuance of the status conference currently scheduled for July 18, 2024, to August 15, 2024, or at the Court's convenience thereafter, to allow Class Counsel and the Settlement Administrator additional time to resolve the remaining objections to the Notices of Rejection of Claims, before presenting them to the Court for resolution.

Status Conference

In its April 3, 2024, Order (Dkt. 984), this Court established deadlines and procedures for distributing the remaining Verified Claims, and allowing payment of "late claims," i.e., pending claims that remained outstanding or deficient at the end of the claim period in October 2023, that were completed as of April 2024. The Court's Order also established a procedure for notifying those whose claims were rejected, including a process for lodging objections to rejections.

Since that time, the Settlement Administrator has issued payments to the remaining Verified Fisher and Property Claimants and issued Notices of Rejection to 39 Fisher and 226 Property Claimants. As of July 3, 2024, the Settlement Administrator has received just 27 objections to these rejections in total, six from Fisher Claimants and 21 from Property Claimants. A few additional complaints have been lodged by those who received settlement awards but were dissatisfied with the amounts.

The Court's April 2024 Order directs the Settlement Administrator to present any remaining unresolved objections to the Court in advance of the next status conference, currently set for July 18, 2024. Class Counsel believes additional time is needed to better attempt to resolve these objections and complaints, to minimize the need for Court intervention in resolving them.

Class Counsel therefore requests that the status conference currently set for July 18, 2024, be renoted for August 15, 2024, or thereafter at the Court's convenience, to approve a plan for distribution of the remainder of the Net Settlement Funds and resolve any remaining objections to Rejected Claims, two weeks in advance of the hearing date.
